WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Non-Controlled Chemicals and Reagents (APP 2024-1st Quarter) with an Approved Budget for the Contract (ABC) of ₱ 2,372,494.91 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on May 15, 2024;

WHEREAS, in response to the Invitation to Bid, one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on May 23, 2024;

WHEREAS, in the public bidding held at the TSU BAC Conference Room on June 5, 2024, at 2:00 P.M.:


