Description

1. The Tarlac State University, through Special Budget (SB) 2025 intends to apply the sum of One Million Three Hundred Ninety-Eight Thousand Five Hundred Seventy-Eight and 63/100 Pesos (₱ 1,398,578.63) to payments under the contract for the project: Construction of Security Guard Locker Room.
Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within ninety (90) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non- discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

6. The Tarlac State University will hold a Pre-Bid Conference on May 27, 2025 (10:00 A.M.) at the BAC Conference Room, 3rd Floor, Motorpool and Administration Building, Tarlac State University, Romulo Blvd., San Vicente, Tarlac City which shall be open to prospective bidders.

Three (3) copies of the bid proposals (one original, and additional copy 1 and 2) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at the office address indicated in the bidding documents, on June 10, 2025 at 9:30 A.M. Failure of bidders to comply with the said request of additional copies shall not be a ground for disqualification.

Late submission shall not be accepted.
